#### **General Conditions:**

- 1. The Service provider must have the valid food license issued by FSSAI.
- 2. No money will be given by the O/o Director, Extension Education Institute, Rajendranagar, Hyderabad as advance; payment will be made after submission of the bill.
- 3. Tax invoice should be issued in favour of O/o Director, Extension Education Institute, Rajendranagar, Hyderabad or the specific department that make order.
- 4. Bills will be settled within one month from the date of submission of bills by the caterer
- 5. All the payments will be made in online or Account Payee Cheque only in favour of the service provider.
- 6. Initially the contract will be given for one year. The respective committee will judge the performance of the establishment after each year. After reviewing the performance, the empanelment may be considered for renewal for a period as deemed suitable by the committee.
- 7. The caterer shall not subcontract to another person/business.
- 8. The caterer should provide quality food and service on time
- 9. The caterer should keep in mind the unit cost/ per head as instructed by the O/o Director, Extension Education Institute, Rajendranagar, Hyderabad while providing foods to the guests/ staff/ students, in case any deviation beyond the per head cost the agency should seek the consent from the responsible official at EEI
- 10. The service should be provided smoothly and hygienically in a professional manner within the prescribed time and place as communicated by the O/o Director, Extension Education Institute, Rajendranagar, Hyderabad. The agency is not supposed to claim/demand any money from the faculty/ guest/ students/ participants for providing the service.
- 11. The cost towards providing Breakfast, Lunch & Dinner, two times snacks and tea duly mentioning the rates for each should not exceed Rs. 600/- (Rupees Six Hundred only) including GST
- 12. EEI shall reserve the right to empanel the service provider at its discretion.

- At least two recommendation letters preferably from Government based organizations based in Hyderabad
- The caterer must have a minimum five years of experience in providing catering services.
- The caterer must have a proven track record of providing catering services to similar organizations/events
